## **promise**

SWMarkets respects the privacy of its website users, therefore, the company undertakes to take all reasonable steps to protect existing and future clients, applicants and visitors.

Apply

To open an account with SWMarkets, you must first complete the necessary information, complete the application form and send it to the company. You need to disclose personal information on the application form so that the company can evaluate your application and comply with relevant laws and regulations. The Company may also use such information to provide you with information about the Services. In addition, we may collect information about you by telephone, email or any other means of communication; including what you enter when you register to use our website, book our services, or conduct activities on our website or other related applications information.

## **Confidentiality and Protection of Customer Personal Data**

SWMarkets is registered with the General Registrar of Vanuatu; therefore, any customer's personal data is kept by SWMarkets in accordance with the laws and regulations of Vanuatu. SWMarkets shall not disclose any confidential information of clients to third parties except as required by regulatory agencies with legal jurisdiction; unless otherwise instructed by regulatory agencies, SWMarkets will try its best to disclose based on the principle of "need to know".

In this case, the company should clearly inform the third party of the confidential nature of the information.

The client agrees and agrees that SWMarkets may contract the company from time to time for statistical or other purposes to enhance the company's business activities; therefore, some or all of the client's personal data may be disclosed.

## **Disclose your information**

We may share your personal information with group members, which means that any subsidiary, ultimate holding company and their respective subsidiaries may receive such information. We may also share your information with certain third parties, including business partners, suppliers, subcontractors and advertisers. For example, in order to provide the services requested by customers, SWMarkets discloses your information to business partners such as card companies or banks; such third parties may save your information to comply with legal and other obligations.

## **Types of Personal Information Collected**

The tracking system used on the company's website will collect detailed information on the pages you visit, how you discovered this website, and the frequency of website visits.

To contact you to provide you with information that the Company believes is useful to you.

Each time you visit our website, we will automatically collect information such as Internet Protocol (IP) address, login information, browser type and version, time zone, and telephone number to call our service hotline. We collect information about you through third parties, such as business partners, subcontractors, advertising companies, analytics service providers, survey information providers, credit investigation agencies, etc.

## **opt-out/opt-out**

If you do not wish to continue to receive any communications from the Company, you may opt-out by following the relevant instructions in each communication sent by SWMarkets. Notwithstanding the fact that you have chosen to launch, SWMarkets reserves the right to contact you as SWMarkets deems necessary.

When a third party other than our agent or service provider collects your personal information, we will notify you of this so that you can make an informed decision whether to share your information with that third party.

## **cookies**

Cookies are small text files that are stored on a user's computer to record information. SWMarkets uses cookies on its website.

SWMarkets uses session ID cookies and persistent cookies. Closing the browser will not end the session ID cookie. persistent cookies
